RELEASE, WAIVER OF LIABILITY, AND COVENANT NOT TO SUE

I hereby acknowledge my awareness that my participation in physical training with Competitive Edge Sports may expose me to risks of property damage and bodily or personal injury, including injury that may be fatal. I am fully aware of and understand the risks involved and hazards to which I may be exposed including, but not limited to, sickness, broken bones, sprains, concussions, injury from balls, bats, and other athletic equipment, drowning, heart attack, and inclement weather. I am fully aware and further understand that I may be exposed to other risks, which may not be foreseeable. I hereby elect to voluntarily participate in physical training with Competitive Edge Sports with full knowledge that such activity may be hazardous to me.
